SUBJECT: Proposed Amendment to the Announcement of the July 23, 2024, Pay

Hearing published via General Circular No. 2024-027

This general circular serves as notification that State Civil Service will present the following Amendment to Exhibit A at the upcoming public hearing scheduled on Tuesday, July 23, 2024, regarding the proposed Classification and Pay Plan changes.

Amendment to Exhibit A: Amended Proposed Protective Services "PS" Pay Schedule Changes Since the Pay Hearing on May 1, 2024. (See Attached)

The attached amended PS Pay Schedule, if approved by the State Civil Service Commission, will replace the original Exhibit A: Proposed PS Schedule as outlined in General Circular No. 2024-027.

Reason for the Amendment:

Proposed Amendment to Exhibit A reflects a recommendation to increase the maximum of the lowest pay grade up 12.4% and to raise the other pay levels in this pay schedule to maintain a 7% midpoint differential to align with current market standards. The decision to amend the exhibit found in <u>General Circular 2024-027</u> from a 25% target to a 12.4% target found in the amendment exhibit is influenced by a desire to adopt a more fiscally conservative approach.

THE CHANGES TO THE PAY PLAN NOTED IN EXHIBIT A AS OUTLINED IN GENERAL CIRCULAR 2024-027 OR THE AMENDMENT TO EXHIBIT A OUTLINED IN THIS GENERAL CIRCULAR REQUIRE APPROVAL FROM BOTH THE STATE CIVIL SERVICE COMMISSION AND GOVERNOR PRIOR TO IMPLEMENTATION. THESE CHANGES WILL NOT BECOME EFFECTIVE UNLESS ADOPTED BY THE STATE CIVIL SERVICE COMMISSION AND APPROVED BY THE GOVERNOR.

As a reminder, the public hearing will be held on Tuesday, July 23, 2024, beginning at 9:00 a.m. in the Louisiana Purchase Room of the Claiborne Building, 1201 Third Street, Baton Rouge, Louisiana.

<u>Please review the proposed Amendment to Exhibit A and furnish State Civil Service with any comments that you consider pertinent by close of business on July 19, 2024.</u>

If you would like to appear before the Commission to present your comments orally, you are invited to do so and are requested to notify Louisiana State Civil Service of such intentions in advance of the meeting.
