#### GENERAL CIRCULAR NUMBER 2025-021

TO: Heads of State Agencies and Human Resources Directors

SUBJECT: Announcement of May 7, 2025 Pay Hearing

The State Civil Service Commission will hold a public hearing on Wednesday, May 7, 2025, to consider proposed changes to the Classification and Pay Plan.
