Louisiana's Civil Service System in large part owes its existence to Charles E. Dunbar, Jr. The enactment in 1940 of the state's civil service laws was the culmination of his 20 years of intensive effort toward this end. This is even truer of the re-enactment (after repeal) of a stronger "merit" law in 1952 with the help of Governor Robert Kennon.

Mr. Dunbar was educated at Tulane and Harvard universities. His distinguished career included, in addition to his law practice in New Orleans, a diversity of civic and community activities. He was president of the Louisiana Bar Association in 1931, and served on the faculty of the Tulane Law School for 25 years. He was a past president of the New Orleans Association of Commerce.

Mr. Dunbar wrote both the 1940 and 1952 Civil Service Law,

and remained active in this endeavor until his death in 1959.

Former Louisiana Governor Sam H. Jones, under whose administration the civil service laws were first enacted, characterized Charles Dunbar as "the kind of man whom a state is ordinarily blessed with about once in a generation. And, if we look over the list of those who have contributed to the public weal in Louisiana in the 20th Century, we can look in vain for more than two or three whose contributions have equaled his, and none who have not had the advantage of public office."

Years ago, when asked to describe his role at DOTD, Kirt wrote, "To challenge institutional paradigms and empower staff to make changes to improve the agency and better the state." Throughout his diverse career, Kirt has led many efforts that have improved DOTD's processes, methods,

and operations, which in turn benefitted the staff of DOTD and the state.

A chemical and environmental engineer, Kirt spent the first half of his career in materials engineering, working to ensure the quality of materials used in the transportation system. In a radical career change, he became the Associate Director at the Louisiana Transportation Research Center, focusing on DOTD's knowledge management and technology transfer programs. From there, he moved to the business side of DOTD to take his current position of Deputy Undersecretary over the Office of Management and Finance.

Asked to name three successes that he would most like to be remembered for, Kirt included his "dream assignment" to create and lead a program to establish a DOTD culture of continuous process improvement and accountability. The nationally recognized Quality and Continuous Improvement Program has analyzed almost 200 DOTD business processes, and involved several hundred employees, industry partners, and other governmental participants in the effort.

He also included the development of DOTD's Workforce Development Policy, and its accompanying Leadership Institute, which established DOTD's training philosophy, expectations, and requirements of its 4,500 employees, and became the precursor to Civil Service's mandatory supervisory training program.

Over the years, Kirt and his wife of 35 years, Patti, who are parents of Christopher and Elizabeth, have contributed their time and talents to their church, their children's schools, and youth baseball. At St. George Catholic Church and School Kirt served in several capacities and was nominated for the diocesan Mother Seton Award.

Aside from his career accomplishments, Kirt may be best known for his "cooking ministry." An avid cook Kirt has catered countless events in support of church, school, charitable fundraisers, and employee events such as retirement parties and recognition programs. Annually, Kirt with a team of DOTD sous-chefs, prepares jambalaya for over 1,000 employees at DOTD's Public Employee Appreciation Event.

Gerrelda Davis has been the Director of the Louisiana Department of Health and Hospitals – Office of Public Health's Bureau of Primary Care and Rural Health since 2007. As director, Gerrelda is responsible for the management and oversight of more than 40 professional and support personnel, as well as the administration

of four service units, including the Chronic Disease Prevention and Control Unit; the Health Systems Development Unit; the Operations Support Unit; and the Practice Management Consulting Unit. These units and their respective programs have a major impact on the emergence, growth and continued viability of healthcare providers, critical access hospitals, federally qualified health centers, parish health units, private and publicly funded primary health care clinics, public hospitals, rural health clinics, rural hospitals, school-based health centers, and small rural hospitals.

Gerrelda has an MBA with a concentration in health care management and a BA in English. She has worked for the department for 18 years, serving in numerous positions including: Disease Intervention Specialist, Training and Development Specialist, Primary Care Officer and Chronic Disease Director. current position as an Engineering Technician 7 in the Project Engineer's Office in Covington.



Mr. Hall began his career in the Division of Administration as an internal auditor where he was assigned to a FACS conversion team under the State Internal Audit Section. During this assignment, he converted general hospitals from manual accounting and payroll processing to FACS, the state's first

statewide central accounting system. After this tenure, Mr. Hall was promoted to the Director of Accounting in the Department of Health and Human Resources.

Mr. Hall was employed by the State Treasury in 1980, and soon after he was promoted to the Chief financial Officer position. Since that time, Mr. Hall has worked under the direction of five state treasurers. Under the direction of state treasurer Mary Landrieu, Mr. Hall was placed in charge of the newly established bid for central banking services for the state. This endeavor allowed the state to pay for central banking services on a fee for service basis in lieu of a compensating balance method resulting in significant cost reductions of banking services for the state.

In 1988, the state had fallen into a position where there were insufficient borrowable resources available to meet the daily cash needs of the state. Mr. Hall was instrumental in the development and implementation of a plan of action, and later, the creation of the Louisiana Recovery District. Born out of this series of events, the legislature incorporated positive processes to ensure that the state never again placed itself in this deficit position, including the creation of the Revenue Estimating Conference and the constitutional and statutory adoption of budgetary controls to manage revenue shortfalls.

Mr. Hall was assigned to the ISIS Steering Committee in 1996 to oversee the conversion of state agencies from FACS to ISIS, the current statewide central accounting system where he was required to ensure that tools were in place to meet the cash management requirements of the state treasury.

In the 1999 Regular Session of the Legislature, Mr. Hall worked with the Senate staff to develop legislation to allow state agencies to accept credit and debit cards and e-checks.

Mr. Hall was honored by the Louisiana State Legislature with a Concurrent Resolution for his many years of service to the state, and the National Guard honored Gary with a certificate for his efforts during Hurricanes Katrina and Rita disasters to ensure funding was always made available to the emergency operations as needed.

says that employment with OJJ can be a life-changing experience for both employees and youth, and that working with delinquent youth is an honorable undertaking. Gwen exemplifies OJJ's philosophy that there is no greater career than public service.

Gwen has steadfastly instilled a sense of ethics in her staff. This is an integral part of who she is: a servant leader. She lives by OJJ's leadership philosophy of setting a good example and modeling the way that leaders should behave.

Gwen has managed three layoffs at OJJ. Gwen was asked to provide services to impacted staff in a large layoff. While serving at DCFS after Hurricane Katrina, Gwen's office telephone number became the point of contact for displaced state employees who had re-located all over the country. She often worked 18 hour days, handling job-related needs and serving as a mentor, spiritual counselor and prayer partner.

She is active in several professional organizations: the Society for Human Resources Management, the LA State Personnel Council, the HR Managers' Association and the National Association of Personnel Executives. She is also a longtime member of the Zodiac Civic and Social Organization, providing services to needy people.

In 10 years of service as her church's Director of Youth Ministries, Gwen taught Sunday School and directed the youth choir and Vacation Bible School. Currently a member of Elm Grove Baptist Church, she serves as VBS instructor, member of the Mass Choir, the Praise Team, and the team that serves meals to the homeless and needy every Sunday.

Colleen Lemoine serves as a Clinical Nurse Specialist specializing in Oncology Services at the Interim LSU Public Hospital. She serves her patients and the hospital by elevating the practice of nursing through research, consultation, clinical excellence, advocacy and education. Her knowledge,

experience and willingness to serve have placed her in a role of advising on current practices and creating new processes.

Ms. Lemoine is the legislative ambassador for the American Cancer Society, representing oncology-related healthcare interests in legislative arenas. She serves on the Executive Leadership Committee and Advocacy Constituent Team (ACT) for the American Cancer Society. Lemoine is also an Advisory Board Member, a volunteer and fundraiser for the American Cancer Society. Additionally, she serves as a Board Member, Chair of Patient Care Services Committee, and a fundraising volunteer for the Leukemia and Lymphoma Society of America. Joyce Majonos accomplishments throughout her 34 plus years of state service are many. She was instrumental in the institution of Statewide Standardization of the Public Hospital Laboratory system for the Health Care Services Division (HCSD). This effort

improved lab analysis and reporting, reduced costly "send out" labs, and demonstrated its success in excess of five million dollars in savings over two years through instrument standardization, volume pricing and reduction in FTEs. Her pride and dedication to her profession are represented in her activities to educate and maintain the highest standards in laboratory practice. She has taught Management at the LSU Health Sciences Center to Pathology Residents and Medical Technology students. Additionally, she has presented both regional and national seminars for the American Society for Clinical Pathology and served on numerous lab accreditation teams for the College of American Pathologists. She served on the statewide committee to evaluate and select the LA Group Purchasing Organization. Committed to maintaining integrity and improvement of her profession, she has served on national task forces and education committees. She also served as Chair of the National Accrediting Agency for Clinical Laboratory Sciences. Joyce represents the image of public employment through being recognized by Who's Who in American Business Leaders, Louisiana Medical Technologist of the Year, MCLNO Department Director of the Year and Honorable Mention Charles Dunbar Career Service Award for distinguished service. She has also received the Dade Behring Lifetime Dedication Award for Medical Technology and the Fisher Scientific Award for service to the profession. She was also appointed by the Governor to serve on the first Clinical Laboratory Personnel Committee for Licensure of Clinical Laboratory Personnel.

For all the changes and projects that Joyce has been a part of in her distinguished career, none can compare to her efforts following Hurricane Katrina. Many of our regional state hospitals used the Charity laboratory for laboratory testing; and efforts to restore services were vital. Joyce was able to orchestrate returning her staff to all points of care necessary within the city. Her crowning glory in this period of transition was the conversion of an abandoned Winn Dixie Grocery Store in Houma, LA into a full service Laboratory.

Joyce is humble in her demonstration of stewardship within the community. She is a private philanthropist to many organizations and individuals. This support is something she takes very personally, as public recognition for her generosity isn't something she seeks. She is a charter member of the WWII Museum and an avid supporter of the N.O. Musician's Clinic. Regretfully, her efforts are most often done with little flare or recognition.

Lt. Colonel Jeffrey Mayne is the Assistant Chief of Law Enforcement for the Louisiana Department of Wildlife and Fisheries. Lt. Colonel Mayne is a 21 year Law Enforcement veteran who began his career as a student worker with LDWF.

The culmination of which has led to a substantial impact on the protection of Louisiana's natural resources and public safety on our State's waterways.

In the course of his career Lt. Colonel Mayne has dedicated himself to protecting Louisiana's natural resources by drafting legislation concerning recreational and commercial trade of fish and wildlife resources. Moreover, his duties as the State's Boating Law Administrator led him to recognize the importance of making our State's waterways safer for recreational boating activities. He determined there was a need for stricter laws to protect the public from impaired operators, thus reducing the rate of fatalities and boating crash incidents on Louisiana's waterways.

Lt. Colonel Mayne's take charge commitment has contributed toward the improvement of the classified service and workplace environment namely by assisting with retirement legislation for Wildlife Enforcement agents that was enacted in 2003 (Act 703). Lt. Colonel Mayne recognized the importance of a complete and comprehensive benefits package and a belief that it is essential to attract, recruit, and retain quality law enforcement personnel to serve and protect, not just our citizens, but also the waterways, ports, environment and ecosystem.

Jeff Mayne has a Master of Public Administration from Louisiana State University, and is a three time Meritorious Service Award recipient for his work in Search and Rescue and Maritime Security. Lt. Colonel Mayne represents Louisiana Natural Resources Law Enforcement on various State, Regional and National committees and working groups. He has been a member of the Louisiana Wildlife Agents Association for over 19 years. Ms. Jama Scivicque began her public service Career in 1972 as a student worker at the Teachers' Retirement System. In 1975, she began working at the Department of Treasury, and has assisted countless state fiscal managers navigate year-end closure activities, fiscal program changes and accounting and tracking systems updates for over the past 36 years.

During her tenure at the Department of Treasury, Jama facilitated the transitional changes to the Department of Treasury brought about by the 1974 Constitution, which included Comptroller and Appropriation control, Social Security Re-organization and Capital Outlay. Ms. Scivicque was instrumental in the 1996 conversion of state agencies from FACS to ISIS, the current statewide central accounting system.

Most frequently, Ms. Scivicque served as fiscal Manager, helping to develop the annual budget request for the Treasury operations, preparing financial statements and providing fund information throughout the fiscal year to legislators and state agencies. She worked with each state agency to review and approve transfers and daily requests for emergency disbursements and wire transfers before funds were disbursed. In addition, she was responsible for reviewing and granting final approval of initial budget upload and mid-year requests in for ISIS for the state budget approved by the Legislature and Joint Legislative Committee on Budget. Also she has been responsible for local government distributions, including state revenue sharing used for losses to homestead exemptions.

Ms. Scivicque is widely respected and admired for her professionalism and the hands-on assistance she has given to fiscal managers throughout the state's fiscal community during her career. Ms. Scivicque has been greatly responsible for the smooth transition from one fiscal year to another and she has steadfastly adhered to the highest standards of honesty and integrity.

The Louisiana State Legislature honored Ms. Scivicque with a Concurrent Resolution thanking her for her many years of service to the state. Additionally, the National Guard honored her with a certificate thanking her for her service during Hurricanes Katrina and Rita to ensure emergency funding was available during the disaster events.

A recycled English instructor who taught at the University of Delaware and LSU, Jean Wall got her first taste of state corrections as a staff researcher on the Governor's Pardon, Parole & Rehabilitation Commission in 1976. In 1984 Jean accepted a job with Corrections. She was part of the team that researched, planned, and implemented in 1987 one of Correction's first alternative programs, a bootcamp-style program known still

as IMPACT (Intensive Motivational Program for Alternative Correctional Treatment).

As with most outstanding employees, Jean's career and challenges expanded to match her capabilities and has included various levels of responsibility. She has served to coordinate and monitor agency legislative packages. She created and edited the Corrections Connection, a departmental newsletter, and its first electronically circulated version FAXFacts. She served as a third-level hearing officer for employee grievances and monitored American Correctional Association compliance. She implemented a basic writing refresher course and in 2009, she even instigated a limerick contest and earned second place among area governmental fundraisers for the Muscular Dystrophy Association.

However, it was in 1993 that Jean received the assignment that has engaged, challenged, and filled her since: define, implement and direct a Crime Victims Services Bureau as central point of contact for crime victims. In this role, she has become advocate, activist, and voice for victims within Corrections.

Collaborating with individuals inside and outside the agency, learning directly from crime victims and from jurisdictions with greater experience, Jean has expanded victim awareness in DOC and victim services by DOC. The initial program focus – victim registration, notification, and information – remains central. Though her regular duties include talking daily with victims/survivors, a related challenge has been to help other employees understand that, even though Corrections is responsible for the care, custody, and control of offenders, before there were offenders there were crime victims, and Corrections has a responsibility to them as well.

Jean's quiet passion and achievements go beyond educational efforts. She initiated and oversaw development and implementation of Victim-Offender Dialogue, managed recruitment and training of program facilitators, and directs on-going operations. She initiated a restorative justice opportunity for offenders, the "Accountability Letter" project, which enables offenders to accept responsibility for their crimes and express regret for harm caused. She engages other agencies and individuals to identify issues and implement solutions in order to make the bureau a meaningful public service. She stands before you today, grateful for opportunities offered and trust afforded and honored to be a recipient of this prestigious award. Even with the demands of her current role, Janice devotes time to support the Girl Scouts of Louisiana East Regional Service Center as an Adult Girl Scout in the Camp Marydale Wrangler program in St. Francisville. She serves in a leadership role for this program in which girls learn horsemanship, teamwork and leadership while providing a riding program for girl scout campers. Now starting her fifth year as a Riding Director at Camp Marydale, she spends one weekend a month at the camp.
